# **Course Calendar Description:**

# **Course Description:**

For the fourth and final year of the Sprott Employability Passport (Business Career Preparation Requirement) students will engage and participate in seven badges by successfully completing and submitting all requirements below to complete BUSI 4995:

In this course you will be required to participate in the following badge activities:

# Career Management

Conduct an Informational Interview with someone who works in an industry that interests you and answer reflection questions.

## **Communications**

You will have a practice / mock interview with the BCMC Team. The mock interview will provide you with the opportunity to practice articulating your skills & knowledge in your field of interest. Prior to the interview, you will choose a job description that best suits your area of business interest and be interviewed based on this job. Optional workshops will be delivered and Interview Resource sheets will be available for interview preparation.



# Professionalism

You are asked to attend one Networking related event and answer reflection questions.

## Leadership

Complete a LinkedIn Learning course online that relates to Leadership. Provide proof of completion and answer reflection questions.

## **Teamwork**

Participate in a team and reflect on the experience.

# **Global Perspective**

Research to find and attend a cultural event that is different from your own culture or background. Answer reflection questions.

#### **Good Business**

Complete community service within your community by volunteering and provide evidence of your volunteer work.

# **Learning Objectives:**

This course will focus on using experiential learning to further develop career ready skills. You will participate in various activities outside the classroom to help you build on the skills you developed in years 1, 2 and 3 of the passport. The goal is to also help with the following:

- 1. Career Management: Develop your job search skills and knowledge.
- 2. Communications: Learn Interview Tips and Strategies, complete a one on one practice interview and receive feedback.
- 3. Professionalism: Understand the importance of networking by attending networking events to practice business etiquette skills.
- 4. Leadership: Know how to lead teams, delegate tasks, solve problems, manage projects and timelines.
- 5. Teamwork: Develop strong collaborative skills when working with peers, colleagues, faculty, and business professionals.
- 6. Global Perspective: Cross-cultural awareness. Demonstrate openness and respect for different cultures and business practices.
- 7. Good Business: Understand the importance of community service and the value in giving back to the community.

# Reading(s)/Textbook(s)/Required Materials (incl. technical requirements, i.e., webcam):

There are no textbooks required for this course. Access to a computer or laptop with internet will be required for the course. A webcam or camera is not mandatory but useful for meetings or presentations.



## Course Requirements & Methods of Evaluation (including due dates):

Students have both fall and winter terms to complete BUSI 4995. All assignments must be submitted at the end of the term, prior to the course deadline. Students are encouraged to promptly submit activities they have completed to help track your progress and always keep a **hard copy** of all your submitted assignments.

This is a non-credit course and will result in either a SAT or IP Grade. To complete the Employability Passport, Bachelor of Commerce students require completion of the four Employability Passport courses: BUSI 1995, BUSI 2995, BUSI 3995, and BUSI 4995. Students have both fall and winter terms to complete BUSI 4995 and all assignments must be submitted by the end of the winter term. Please be advised that BUSI 4995 must be completed as part of the degree requirements prior to graduation from the Bachelor of Commerce.

IMPORTANT NOTE: Successful completion of BUSI 4995 is required for graduation from the Bachelor of Commerce Degree Program.

## **DEADLINES:**

The deadline for Registration for the 2021 Fall Term is Wednesday September 22, 2021.

Although the 2021 Fall term officially ends on Friday December 10<sup>th</sup>, 2021, the deadline to have all of your work completed and submitted for the Fall Term is end of the day (11:59 pm) on <u>Friday November 26<sup>th</sup>, 2021</u>. This will give you time to correct and resubmit your badges if they are declined.

studies at Carleton; expulsion from Carleton, amongst others. For a first offence, at a minimum, the penalty assigned will normally be a zero on the submitted work and at least a minimum full grade reduction of the final course grade.
