### Prerequisites & Preclusions:

Prerequisites: BUSI 2002 with a grade of C- or higher.

Precludes additional credit for BUSI 2011, BUSI 3011 and BUSI 4011.

### Course Calendar Description:

Accounting problems associated with business combinations, with attention to the preparation of consolidated financial statements. Discussion may extend to financial reporting and diversified companies, reorganizations, etc. Selection of topics may vary from year to year.

### Instructor's Description:

Discussion of accounting issues and problems associated with business combinations, long-term intercorporate investments, diversified operations, foreign operations and not-for-profit organizations. Equity accounting, preparation of consolidated financial statements, and foreign currency translation are given particular attention.

### Course Learning Objectives:

Understand, interpret, apply and critically evaluate the accounting treatment for: Non-controlled investments; Control investments (wholly owned, and non-wholly owned); Joint arrangements; Foreign currency transactions and translations; and, Non-profit organizations

**Assignments:**

Assignments for this course will be posted on Brightspace. They are designed to help you practice and reinforce key concepts covered in class and are directly aligned with the types of questions you'll face on Test 1 and Test 2. Assignments may be completed directly in Brightspace or using Microsoft Excel, depending on the task. You may work individually or with a classmate. If working with a partner, only one of you needs to submit the assignment, but be sure to include both names clearly on the submission.

Each assignment is worth 2.5% of your final grade, for a total of 10%. However, these marks are participation-based, not performance-based: you earn them by completing the assignments by the deadline.

Assignments may be marked and/or feedback may be provided, but the scores are for learning purposes only, they will not directly affect your final grade. If you can't for any reason (or choose not to) submit an assignment by the deadline, you simply don't receive the participation credit for that assignment. The weight will instead be automatically reallocated to the relevant test. This means you won't be penalized for skipping an assignment, but your tests will carry slightly more weight.

Assignment submissions that are superficial, incomplete, or insincere may receive a grade of 0% or 50%, and that grade will stand, it will not be shifted to a test. You are expected to demonstrate a reasonable level of engagement with the material. If you do not have time to complete the work properly, do not submit it and instead allow the weight to be transferred to the relevant test.

**Sample Tests:**

Sample Tests for this course will be posted on Brightspace. They are designed to help you practice and reinforce key concepts covered in class and are directly aligned with the types of questions you'll face on Test 1 and Test 2. Sample Tests may be completed directly in Brightspace or using Microsoft Excel, depending on the task. All work must be completed individually. After you submit your Sample Test attempt, you will gain access to both the full set of solutions to support your learning.

Each Sample Test is worth 2.50% of your final grade. These marks are participation-based, not performance-based, and are earned through a short self-grading process. Once you receive the solutions, you will assess your own attempt using the provided answer key, as if you were a Teaching Assistant. You will then submit your graded attempt along with the score you assigned yourself. The self-assigned score will not affect your grade, and you will earn 2.50% for completing the process.

Similar to the assignments, if you choose not to submit a sample test self-grade by the deadline, you simply don't receive the participation credit for that sample test. The weight will instead be automatically reallocated to the relevant test. This means you won't be penalized for skipping a sample test, but your tests will carry slightly more weight.

Sample Test attempts or self-grading submissions that appear superficial, incomplete, or insincere may receive a grade of 0% or 50%, and that grade will stand, it will not be shifted to a test. You are expected to demonstrate a reasonable level of engagement with the material. If you do not have time to complete the work properly, do not submit it and instead allow the weight to be transferred to the relevant test.

## **Grading and Feedback**

Assignments may be reviewed by the Instructor and/or Teaching Assistants, with a consistent quality control process to ensure fair and constructive feedback. You may receive a score and comments, but this score is informational only and will not impact your final grade.

There is no formal appeal process for assignment scores, as they do not contribute directly to your grade. That said, if you believe a mistake was made or would like clarification on feedback, feel free to reach out via Carleton email, after class, or during office hours. These assignments are an opportunity to engage meaningfully with the material, and I welcome those conversations.

## **Test 1 & Test 2:**

Test 1 will cover Chapters 1 to 6 and will be written on campus. It will be scheduled by Scheduling and Examination Services **sometime between June 21 - 27, 2026**. The duration of Test 1 is 2.0 hours. A deferred sitting of Test 1, for extenuating circumstances - subject to approval at the discretion of the Instructor, will be held on **Monday, July 6, 2026**, from 7:15 AM to 9:15 AM.

Test 2 will cover Chapters 7 to 11 and will be written on campus during the **formally scheduled Final Exam period**. The duration of Test 2 is 2.0 hours. The University will schedule a deferred sitting of Test 2, for extenuating circumstances - subject to approval at the discretion of the Registrar's Office, between September 18-20, 2026. Note that access to Brightspace will be removed on August 31, 2026 for all students regardless of whether you deferred the exam.

Both tests may include technical and conceptual material. Students writing on campus will have the choice to complete the tests on paper or using Excel in CoMaS. Distance students and/or students who sit a deferred test will only be able to complete the test on paper.

This course is designed to prepare you for the CPA Professional Program and its associated examinations. Consistent with that objective, no "cheat sheets" are permitted during exams. The assessments are intended to evaluate your ability to apply and demonstrate the knowledge you have developed, rather than rely on external reference materials.

Both Test 1 and Test 2 are summative assessments, similar in nature to a traditional final exam. Their primary purpose is to evaluate your understanding of the material at the end of each half of the course. As such, detailed grading / feedback will not be provided beyond your score and, where applicable, class-wide commentary.

This is also why the course uses a split-test model (Chapters 1 to 6 and Chapters 7 to 11), rather than a traditional Midterm / Final Exam structure. Material tested on Test 1 is not retested on Test 2. This approach allows you to focus your efforts on mastering each half of the course independently and avoids redundancy. Unlike a traditional midterm, Test 1 is not a rehearsal for a final exam. It carries meaningful weight in your Final Grade and assesses material that will not be re-tested later in the course.

As with final exams, full solutions to Test 1 and Test 2 will not be distributed, and written feedback will not be provided. If you have questions about your test scores, you may request to review your test in person. The goal of the review is to allow you to verify that your test was marked fairly, not to rework or appeal specific answers. Requests to review your test must be made within seven calendar days of the grade being released, and reviews will be scheduled at the Instructor's discretion.
