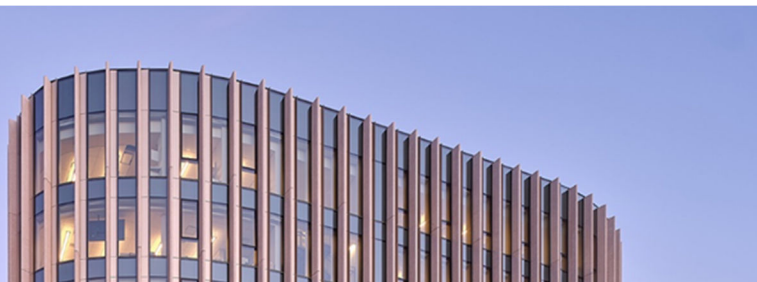

Finally, the course prepares students for more advanced courses as well as prepares them for future careers.

2. Understand how and where financial securities are traded and how they are valued
3. Develop an understanding of how investors allocated funds across different financial instruments.
4. Appreciate various aspects of modern financial markets as well as emerging current and future trends.

Two Term Tests will be held **in-person, in class, at the beginning of class on October 8th and November 12th**. The term tests are closed-book. Material covered up to and including the class before the term test is eligible to be addressed.

The **Final Exam** will be a comprehensive test, covering material from the entire course. More information about the midterm and final will be provided in class as the term progresses.

The Trading project – on StockTrak is described in detail on the course website; you may participate in this project individually or with a partner of your choice. The cost of each account is US\$34.95 per student.

The attendance bonus is based on attending weekly classes. Attending all classes will result in a bonus of 2%; partial bonus marks will also be awarded for the number of classes attended.

FinTech Presentation

This is a chance to earn up to an extra 1% bonus on the course if you choose to participate! The format will be a 10-minute PowerPoint presentation that you deliver in groups of 5 students. Presentations will take place in class on December 7th. You can form your own group and choose your own topic under the theme of FinTech and emerging topics in investments. There will be a sign-up sheet and topics will go on a first-come-first-served basis. This is your chance to have fun while teaching your classmates something new! Sample topic ideas include, but are not limited to:

- Cryptocurrencies (pick only one topic from below):
 - Illegal transactions using Bitcoin
 - Initial Coin Offerings
 - Blockchain technology outside of finance
- Peer to peer lending
- Robo advising
- High-frequency and algorithmic trading
- Social media in financial markets
- AI-driven portfolio optimization
- Machine learning for risk management
- Natural Language Processing in market sentiment analysis
- Another topic of your choice!
