# **Prerequisites:**



BUSI 1002 or BUSI 1005, BUSI 2504 with a grade of C or higher in each; ECON 1001 and ECON 1002 (or ECON 1000) and MATH 1009 with a grade of C- or higher in each. The School of Business enforces all prerequisites. Only the Undergraduate Program Supervisor of the School can waive prerequisite requirements.

This course BUSI2505 is prerequisite to BUSI 3500, BUSI 3502 and BUSI 3512 (with a grade of C+ or higher).

#### **Course Description**

Capital investment and financing decisions in the context of risk and return tradeoffs. Primary and derivative securities, and their role in risk management. Mergers, corporate restructuring, the theory of principal-agent relationships, and financial planning, forecasting, and control.

The topics covered in BUSI 2504 will be extended in this course, exposing students to a broad range of material pertaining to Business Finance and Financial Management. Topics covered include: capital budgeting under uncertainty, capital structure analysis, dividend policy, mergers and acquisitions. Students will learn principles for making sound decisions about financing (obtaining funds) and investment (using funds) when facing an environment with risk and uncertainty.

# **Course Objectives**

The course explores how value can be created through investment and financing decisions, and the management of risks associated with such decisions. The aim is to (1) provide a description of corporate financial management and the role of the financial manager, (2) to discuss the role of financial markets and institutions that facilitate the process of financial

management, (3) to explore the process of making capital investment, financing decisions and dividend policy.

# **Learning Outcomes:**

- Develop proficiency in the areas of asset valuation and project evaluation
- Determine the relevant cash flows for a proposed investment and apply NPV criterion using projected cash flows.
- Evaluate the merits of alternative techniques used to evaluate long-term projects.
- Understanding the importance of capital structure and how it can affect firm value and cost of capital
- Introducing international finance, mergers and acquisition

Tips: the course makes frequent use of financial models that you learned from BUSI 2504. Please review your old notes before attending the lecture. The majority of the classes will be comprised of lectures and solving for in-class problems.

**NOTE**: Students who do not demonstrate a minimum level of performance during the term will not be allowed to defer the final exam. The requirement for satisfactory in-term performance is an overall mark of 50% or better on the assignments and test. Students with unsatisfactory in-term performance who miss the final exam will be awarded FND for the course.

**NOTE**: The final exam will be comprehensive, covering material from the entire course. If you are awarded less than 40% on the final exam, you will receive an "F", regardless of your total mark in the course.

Every effort will be made to mark fairly and accurately. None the less, in some cases, students may call into question the grades awarded to assignments or tests. In such cases, please write a brief note describing the difficulty with the awarded grade and provide the note, together with the graded work, to the instructor not later than seven calendar days following the return of the graded work. Please be sure to include your name and student number on the note to enable the instructor to identify it properly. Note that the resulting remarking may lead to a lower grade.

There may be cases in which a student is permitted by University regulations to miss a graded component of the term work in a course. For example, the only acceptable reason to miss a midterm is due to medical or family emergency with a note from a doctor. In such circumstances there will be **no make-up assignment or test**. The grade weighting corresponding to the missed component will be added to the grade weighting of the final exam.
