# **Auditing I**

Auditing theory, methodology and application.

Precludes additional credit for BUSI 4007 (no longer offered).

Prerequisite(s): BUSI 2001

#### **Course Description:**

The course begins with an examination of the principles and theory which underlie the practice of auditing financial statements. In particular, concepts of management assertions, audit objectives, evidence, materiality and risk, internal control, audit planning, and reporting are examined and discussed. The course also examines auditing as a professional activity, including topics such as professional judgement, ethics, legal liability, and the responsibilities of auditors to society. Other assurance engagements are also addressed.

# **Learning Outcomes:**

By the end of this course students will be able to:

- 1. Explain the audit process.
- 2. Assess risk and materiality.
- 3. Demonstrate audit procedures appropriate to a set of circumstances.

- 4. Understand and apply the concepts of machine learning and artificial intelligence
- 5. Evaluate the audit report.
- 6. Apply professional standards, including to ethical issues and legal situations.
- 7. Critique developments in the profession.
- 8. Compare financial statement audits and other assurance engagements.

#### **Satisfactory In-term Performance**

The requirement for Satisfactory In-term Performance is set at 50% of all, not each, term work (i.e. quizzes, midterm examinations, group work, etc.). Note, however, that Satisfactory In-term Performance of 50% may not be sufficient to permit registration in advanced courses in the accounting program and may not be sufficient to be recognized by professional accrediting bodies.

# Quizzes (2 quizzes 5 percent each) - Optional

Given the significant volume of material and number of new concepts that are introduced in this course, there are two brief quizzes scheduled. This should assist students in keeping up with the material and getting timely feedback on their progress and opportunity to test knowledge and understanding of the material. Each quiz will be approximately 30 minutes in length and consist of multiple choice and/or short/long answer questions. The completion of these quizzes is optional. If you chose to write them, your quiz grade will only count in the calculation of your final course grade if it **increases** your grade. If you chose (or cannot) write the quizzes, the final exam will be worth 45% of your grade. Requests for reconsideration of a quiz grade must be submitted in writing within 7 calendar days of the quiz date. Quizzes will be administered online via CuLearn. Instructions and details will be provided in the week prior's announcement.

# **Group Project – External Audit Simulation (22 percent)**

The Sprott School of Business encourages group assignments in the school for several reasons. They provide you with opportunities to develop and enhance interpersonal, communication, leadership, follower-ship and other group skills. Group assignments are also good for learning integrative skills for putting together a complex task. You have been assigned one group project in this course. Before embarking on a specific problem as a group, it is your responsibility to ensure that the problem is meant to be a group assignment and not an individual one.

Groups of approximately five students will be originally formed the after the first week of class. Each group will participate in an external audit simulation of the company ColAlta Pipeline. Details of this project (due dates for various components of the project are indicated in the Detailed Course Schedule) will be provided on CuLearn. Written reports for each component of the project are required to be submitted in word format. These are to be submitted online by the date and time indicated in the detailed course schedule. Students are reminded to always retain a hard copy of all the work they submit. Should any conflicts or issues arise within a group over the course of the project, the student(s) are expected to discuss issues in a timely matter with the Course Instructor and/or TA.

#### Mindbridge Ai University Alliance Cases (8 percent)

The Sprott School of Business has partnered with MindBridge Ai to participate in the MindBridge University Alliance Program. MindBridge Ai is the global leader in applying machine learning and artificial intelligence to financial data analysis. The MindBridge Ai Auditor platform is an intuitive platform that empowers auditors to analyze financial data more efficiently, while augmenting human capacity to uncover errors and intentional misstatements in the data. The program will include hands-on case studies, where students have access to the Ai Auditor program to perform required analysis. Case studies are focused on fraud detection analysis, while reinforcing AI auditing principles. The program will require students to complete three case studies and one assignment. These cases are expected to be completed on an individual basis. Upon the completion of the assignment and receipt of grades, the student will receive a certificate of completion of the program.

#### Midterm Examination (25 percent)

One midterm examination is scheduled (see the detailed schedule for midterm date) and will be 2 hours in length. All assigned readings from the textbook/cuLearn and material presented in the video lectures are examinable. Upon release of the midterm grades the student will have 10 calendar days to review their results and report any discrepancies to the professor. Any discrepancies reported beyond that time may be reviewed but will not result in any change in grade. Students who miss a midterm examination and provide appropriate documentation within 5 calendar days of the midterm date may have the weighting of the midterm allocated to the final exam. There will be no deferred mid-term examination held.

#### Final Examination (35 percent)

A final examination will take place during the university scheduled final exam period. The date will be announced by Scheduling and Examination Services. The duration of the exam will be 3 hours. All assigned readings from the textbook/cuLearn and material presented in the video lectures are examinable. The final exam is cumulative. University policy with respect to examinations will be strictly adhered to. Supplemental and grade rising examinations are not available. Notwithstanding the marking scheme, if the mark on the final exam is less than 45%, the final grade for the course will be an F.

Both the midterm and the final examination must be completed in Word & Excel only. No handwritten responses will be accepted.

The exams will be conducted online via CuLearn (through Quiz and/or a downloadable word document) and will be closed-book exams subject to e-proctoring.

#### **Organization of Files in CuLearn**

The online material for each week follows a standard structure. Begin with the Required Readings folder. An outline of the requirements for the week will be provided in the weekly materials. Lecture slides are included in their own folder. Under the Lesson folder (the icon with the linked folders you will find the learning objectives for each week, all the videos for the week, and practice questions for the week. Depending on the week, there may also be assignment submission buttons and/or additional resources.

# **Late Assignments:**

To ensure fairness for all students, penalties will be applied to late assignments: Failure to submit an assignment on time will result in a penalty of twenty (20) percentage points per day up to a maximum of one day late. For example, an assignment that would normally merit a grade of 80% would receive a grade of 60% if submitted the following day. Assignments will not be accepted at all after the following day and a grade of 0% will be awarded. Given the fact assignments are open and able to be worked on at any time during the course up until the deadline, no requests for extension will be considered - this means do not wait until the last minute to attempt or submit the assignment.

#### **How to do Well in this Course:**

This course covers A LOT of material. Keeping up with the weekly material online and completing the assignments is certainly important, but making sure to prepare many practice problems on your own, using the practice problems provided and exercises in your textbook, is critical if you want to do well in this course. Please post questions in the cuLearn discussion forums if you do not understand something.

To perform well in this course, you must spend time answering the practice questions and textbook problems and checking the answers to test your understanding. To maximize your learning, you should make an honest attempt at the question before consulting the solution. Simply reading a question and then turning to the solution right away will not be help you apply your knowledge to the material.
