**Course Calendar Description:** Techniques for using data to make an informed use of statistics. Applications, interpretation and limitations of results. Sampling, descriptive statistics, probability concepts, estimation and testing of hypotheses and regression, using practical business situations.

#### Learning Objectives:

To understand fundamental data analysis results To recognize limitations in statistics

**Course Prerequisites:** No prerequisite courses. Students are expected to know basic math (e.g., order of operations, solving for one unknown variable in one equation).

To help you learn, there are assignments on CULearn, corresponding to certain modules. The purpose of each assignment is to reinforce your understanding of that module's material. Do assignments individually, not as a team. You could start assignments 1, 2, and 3 by August 30; but do not press "submit" unless you are certain. Submitted assignments cannot be returned by CULearn. Assignments will be graded only after their deadline. Please come to the office hour for help with assignments.
