Course Calendar Description:

An introduction to the knowledge and tools required for a career in Business. Includes: Experiential Learning Activity **Prerequisite(s):** Restricted to students registered in B.I.B. Participation in employability events and initiatives throughout the year.

Course Description:

BUSI 1996 is one of the courses in the four-year career development program to equip Sprott School of Business students with the job-ready skills and awareness to find meaningful employment and career success. This program complements the academic knowledge and skills gained through Sprott's undergraduate business degree programs.

As the first step in this course, all students **must** book a "1st Year Employability Passport – First Steps (BUSI 1996)" appointment with a Business Career Management Centre (BCMC) Career Coordinator to discuss and explore career goals. This will help students foster a plan on what activities will help them achieve their goals as they progress with the Employability Passport. Lastly, all students **must** complete the mandatory Career Readiness Survey Question.

Learning Outcomes:

For BUSI 1996, Sprott Employability Passport (Business Career Preparation Requirement) students will engage and participate in two badges by successfully completing and submitting all requirements below to complete BUSI 1996:

1. **Career Management**: Attend a MANDATORY Business Resume Workshop and develop a draft resume.



2. Wellness: Self enroll and complete "Here you are" course on Brightspace.

Learning Objectives:

In this course you will use experiential learning to develop career ready skills. You will participate in various activities outside the classroom to practice the soft skills you develop through workshops and extra-curricular activities. The goal is to also help with the following:

- 1. Career Management: Learn to craft a strong business resume.
- 2. Wellness: Understand and manage your mental health and well-being.

Reading(s)/Textbook(s)/Required Materials (incl. technical requirements, i.e., webcam):

There are no textbooks required for this course. Access to a computer or laptop with internet will be required for the course. A webcam or camera is not mandatory but useful for meetings or presentations.

Course Requirements & Methods of Evaluation (including due dates):

All assignments must be submitted at the end of the term, prior to the course deadline. Students are encouraged to promptly submit activities they have completed to help track your progress and always keep a **copy** of all your submitted assignments.

This is a non-credit course and will result in either a SAT (Satisfactory) or UNSAT (Unsatisfactory) Grade.

All students who have not completed the course by the end of each term will receive an UNSAT and MUST register themselves for the following term for the course.

IMPORTANT NOTE: Students require completion of BUSI 1996 and BUSI 1997 to be eligible for registration in BUSI 2702.

For a first offence, at a minimum, the penalty assigned will normally be a zero on the submitted work and at least a minimum full grade reduction of the final course grade.
