COURSE DESCRIPTION

A foundation course that aims to introduce the fundamental concepts of income tax laws and regulations as significant elements in the planning and decision-making process of taxpayers and managers. Problems, issues and planning associated with the Income Tax Act are discussed.

LEARNING OBJECTIVES

Taxpayers cannot make intelligent personal or business decisions without considering the tax implications of their choices. An understanding of Canadian taxation is therefore necessary. This course is an introduction to tax principles and practice and is designed to achieve the following objectives:

- 1) To explain the theoretical concepts behind the specific provisions of the law,
- 2) To apply the law in practical problems and case settings,
- 3) To interpret the law, taking into account the specific wording of the provisions, judicial decisions and the Canada Revenue Agency's position, and
- 4) To introduce basic tax planning concepts through case application.

This course introduces fundamental principles, personal and corporate income tax, and specialized topics (e.g., GST/HST).

Notes:

- 1) The maximum achievable grade is 5% (which means you can 'miss' 2% of these and still earn full marks)
- 2) I wanted to include tax clinic participation in the course as it is a fabulous experiential learning opportunity, allowing students to work with tax software and prepare personal tax returns for Canadian taxpayers. That said, I recognize that not all students are located in Ottawa or may not be available at the defined times to participate in a tax clinic. For those students, you have a couple of options:
 - a. You could earn up to 2% by completing two incentive program workshops by April 12 (1% each; see instructions on Brightspace).
 - b. You could earn a full 5% by completing the other items listed above.

Assignments are done individually; however students wishing to work in pairs *may seek* special permission from the instructor to do so before Assignment 1 is due. The instructor will ask for a meeting with both of you to discuss the nuances of working in pairs.

Because of the possibility some students will be working in pairs, ALL students must register for a 'group' on Brightspace, even if you are the only one in the group (I know, it's silly! Just do it.) Instructions:

- 1) On the BUSI2005 course Brightspace page, select "Tools" in the top menu bar to see the drop down list.
- 2) Select 'Groups' from this drop-down list.
- 3) If working alone, simply add yourself to a group that has 0 individuals in the group. If working in a pair, you and your partner must agree on a group # which has 0 individuals in it, and both add yourself to *that* group.

<u>Late assignment policy</u> - "Days of Grace": The assignment deadlines are at least one week after the completion of related course material (sometimes more) and as such, should be sufficient. Yet, sometimes, despite our best efforts, and for good reasons, we can't meet our deadlines. You have TWO days of grace that you can apply to missed assignment deadlines. For example, a single assignment may be two days late or two assignments may each be one day late with no penalty. No reason required. No questions asked. That said, <u>I</u> need an email before the deadline indicating you will be late, but plan on submitting. It's important to me to post the solution as soon as possible for the other students, as quick access to the solution is a best practice for learning. I don't want all students waiting for submissions that aren't coming. Once the two days have been used, no further lateness will be accepted and any late submissions at that stage will receive 0.

Final exam

The final examination will be held in the regular examination period (Apr 15-27). The duration of the exam will be 3 hours. The final examination will cover the whole course. You need to obtain a minimum of 45% on the final exam to pass this course.

The default assumption is that students will write the final exam in-person on campus. If a student is not be able to come to campus because they are studying remotely, they can apply to write at a distance (https://carleton.ca/ses/distance-exams/). We will be leveraging automated e-Proctoring software, to ensure integrity of the test/exam process. However, we recognize that there may be exceptional circumstances that prohibit the use of technology (i.e., technical infrastructure issues), and for these cases, students may apply to have an in-person, proctored, exam at an eligible post-secondary institution. There is a cost associated for this service: \$92 for those writing within Canada, and \$165 for those writing outside of Canada. If technology is leveraged, the international fee will be waived in favor for the within Canada rate. For students who require the use of a proctor at a post-secondary institution, the student will also be responsible for this additional fee. Students need to apply for this service by January 25, 2023.

<u>e-Proctoring</u>: Please note that remote examinations in this course will use a remote proctoring service provided by Scheduling and Examination Services. You can find more information at https://carleton.ca/ses/e-proctoring/.

I make an effort to reduce unintentional bias in grading by, for example and when possible, grading anonymously, using clear and specific rubrics, and grading tests one question at a time (grading all of question 1 before grading any of question 2), etc.
