1. Individual Mini Case Analysis Exercise (10%) – January 30

Ten percent (10%) of your grade will be based on an Individual Mini Case Analysis Exercise. This assignment is due on **Monday, January 30 and must be emailed to me before 11:00 p.m. on the due date.** The Mini Case Analysis Exercise and instructions are presented on the course web site.

2. Midterm Test (in classroom) (30%) – February 13

The Midterm Test will be held in the classroom during the regularly scheduled class time on **Monday**, **February 13**. You must write this test at the scheduled time or present a medical certificate to explain why you can't. If you present a medical note for a missed midterm exam, a makeup exam will be

provided for you. The test will cover all material in the textbook and lectures up to and including the class prior to the midterm test (i.e., **Chapters 1, 2, 3, 4, 5, 12, and lecture material**). At least 60% of the test will be based on the material covered in the lectures.

3. Group Case Analysis Report (30%) – March 27
