## **Course Calendar description:**

An advanced course in the knowledge and tools required for a career in Business.

Includes: Experiential Learning Activity

Prerequisite(s): BUSI 2995.

Participation in employability events and initiatives throughout the year.

#### **Course Description:**

For the third year of the Sprott Employability Passport (Business Career Preparation Requirement) students will engage and participate in five badges by successfully completing and submitting all requirements below to complete BUSI 3995:

- **1. Career Management**: Attend one of three Job Search related events offered by BCMC (Interview Prep, Advanced LinkedIn Workshop, or Job Search Strategies Workshop) and complete and submit a reflection for the workshop. International Students have a fourth option and are encouraged to consider attending a minimum of one out of five workshops offered in the series called "Navigating the Canadian Workplace", run by Career and Co-op Services which you can register for using the Career Co-op Workshops selection on MySuccess Dashboard.
- **2. Communications**: Interview Preparation. Refer to Interview Resources and /or Attend the "Interview Preparation" workshop then use Kira Talent to complete a virtual practice interview.
- 3. **Leadership**: Choose one non-academic activity that you have participated in where you gained or demonstrated leadership skills during this academic year and complete and submit a reflection document. **OR** complete 1 of 3 LinkedIn Learning Leadership related courses online, answer Qs and load certificate of completion.



- 4. **Global Perspective**: Choose one country of choice that you are not living in currently. Research and understand the business customs of that country. Complete and submit a summary of your findings.
- 5. **Technology**: 3 options: Create an account with either Amazon Web Services, IBM or LinkedIn Learning, complete an online learning module relevant to Technology and submit proof of completion.

## **Learning Objectives:**

This course will focus on using experiential learning to develop career ready skills. You will participate in various activities outside the classroom to help you build on the skills you developed in years 1 and 2 of the passport. The goal is to also help with the following:

- 1. Career Management: Develop your job search skills and knowledge.
- 2. Communications: Learn Interview Tips and Strategies, complete a virtual practice interview, using Kira Talent.
- 3. Leadership: Know how to lead teams, delegate tasks, solve problems, manage projects and timelines.
- 4. Global Perspective: Cross-cultural awareness. Demonstrate openness and respect for different cultures and business practices.
- 5. Technology: Learn new technology skills that is used and/or relevant to the industry in which you would like to pursue a career.

# Reading(s)/Textbook(s)/Required Materials (incl. technical requirements, i.e., webcam):

There are no textbooks required for this course. Access to a computer or laptop with internet will be required for the course. A webcam or camera is not mandatory but useful for meetings or presentations.

#### **Course Requirements & Methods of Evaluation (including due dates):**

Students may complete BUSI 3995 over two terms or one term. All assignments must be submitted at the end of the term, prior to the course deadline. Students are encouraged to promptly submit activities they have completed to help track your progress and always keep a **copy** of all your submitted assignments.

This is a non-credit course and will result in either a SAT (Satisfactory) or IP (In Progress) Grade. All students who have not completed the course by the end of each term MUST register themselves for the following term in order to be able to continue working on completing their badges for the course. (e.g. A student who registered for 3995 in the Fall did not complete by the end of the Fall term MUST register for the Winter Term in order to be able to continue working on the course requirements. If this student does not complete the course by the end of the Winter Term, they MUST register for and SUCCESSFULLY complete BUSI 3995 by the end of the summer term).

IMPORTANT NOTE: Successful completion of BUSI 3995 is required for registration in any course that requires fourth year standing.



## **DEADLINES:**

The deadline for Registration for the 2022 Fall Term is Tuesday, September 13<sup>th</sup>, 2022.

Although the 2022 Fall Term officially ends on Friday, December 9<sup>th</sup>, 2022, the deadline to have all of your work completed and submitted for the Fall Term is end of the day (11:59 pm) on Friday, November 25<sup>th</sup>, 2022. This will give you time to correct and resubmit your badges if they are declined.

#### **Course Schedule:**

## **Academic Integrity**

For a first offence, at a minimum, the penalty assigned will normally be a zero on the submitted work and at least a minimum full grade reduction of the final course grade. For a second offence, at a minimum, the penalty assigned will normally lead to a suspension from studies.
