# Course Calendar description from the 2021/2022 University calendar:

Fundamentals of managerial accounting and control. Techniques for management decision-making, planning, and control including cost-volume-profit analysis, product costing, variance analysis, relevant costing, transfer pricing and the balanced scorecard. *Precludes additional credit for BUSI 5005 (no longer offered). Prerequisite(s): <u>ACCT 5001</u>.* 

# **Course Description:**

ACCT 5002 is a managerial accounting course. Accounting has often been called "the language of business". This course is designed to help you begin to understand and communicate in this language - something that is important for all users of accounting information, not just preparers of it.

The ACCT 5002 course focuses on the basic managerial accounting concepts and tools that aid internal managers in decision making to make optimal financial decisions. Major topics addressed in this course include: cost and cost behaviour, short and long-term decision-making, activity-based cost systems and budgeting and control issues. The ability to apply the concepts learned in real world cases and working in groups is also emphasized in this course.



# Learning Outcomes:

Upon completion of this course, students will be able to:

- 1. Possess a general understanding of the nature of management accounting, its concepts and principles;
- 2. Apply internal accounting information for to arrive at key business decisions;
- 3. Critically analyze and interpret management accounting information;
- 4. Understand the role of performance measurement and the control function in organizations.
- 5. Identify costs and cost behaviour and there use in costing and decision making for short and long-term decisions.

# Assignments (1 individual, 1 in pairs) (30% total)

The assignments include short cases and problems posted to Brightspace. They are completed **individually**. Students are expected to submit their assignment via Brightspace before class. If it is not submitted on the due date, it will be considered late and subject to a **100% PENALTY**. **MAKE-UP ASSIGNMENTS ARE NOT PROVIDED**. Plagiarism will result in a zero grade for all involved.

#### Hand-in Case (20%)

There will be one hand-in case to submit via Brightspace. The assignment will present a case for you to address and resolve. The assignment will be completed in groups of 2 people and the final mark is the grade for the group. Students are expected to submit their assignment via Brightspace by the due date. If it is not submitted on the due date, it will be considered late and subject to a **100% PENALTY. MAKE-UP ASSIGNMENTS ARE NOT PROVIDED**. Plagiarism will result in a zero grade for all involved.

### Final exam (50%)

The final exam will test technical and theoretical aspects. The exam will cover the whole course. You must achieve at least a combined 45% grade on the final exam to pass this course. Students will receive an exam and expected to respond with a written response. The exam will be time limited.

FINAL EXAM time to be announced. The written final exam date will be announced in due course. You have the option to write in person on campus or at home. Note that if you decide to write at home the exam will be written using Carleton's e-proctoring service. That is, it will be online, but you will be monitored by proctors for the entirety of the exam. # **OPTIONAL: Exam interview (verbal exam) (15%)**

The individual verbal final exam interview requires a one on one interview with the teacher. The verbal exam will cover concepts taught in class requiring the student to respond with an appropriate answer. There will be an initial question(s) with follow up questions to confirm understanding and will test technical and theoretical aspects. This will be a closed book exam. You must achieve at least a combined 45% grade on the final exams to pass this course.

### Satisfactory In-term Performance

- The requirement for Satisfactory In-term Performance is set at 50% of all pre-final term work (i.e. assignments).
- Unsatisfactory In-term Performance in this course will lead to Failure in this course (regardless of the performance at the Final exam).

# 2. Do the work. Practice. Practice. Practice.

To perform well in this course, you must spend time answering extra problems and checking the answers to test your understanding. To maximize your learning, you should make an honest attempt at the question before peeking at the solution.

Simply reading a question and then turning to the solution right away is next to useless. You will find that there is a direct correlation between the number of problems you prepare, your attendance in class and your course grade.

Accounting is not a difficult subject to learn if you practice. Simply, accounting is PRACTICE, PRACTICE, PRACTICE.

# **FINAL THOUGHTS**

This is not a course to register in if you are seeking easy credit. For many students, this course is a challenge. Part of the challenge stems from the subject matter, but the biggest difficulty comes from failing to devote enough effort to working with the material. Like calculus and other courses where no two problems look alike, accounting requires that you practice working with it—over and over and over. You are unlikely to learn by merely watching someone else (i.e. me) "do accounting."
