**Modality:** This course will be offered both synchronously (live **online** during course time) and

asynchronously (pre-recorded sessions, **online**) with components of synchronous class time being held between the scheduled course slot of Tuesdays from 2:30pm to 5pm EST. Synchronous sessions will typically run for no more than **60-90** minutes per class and where possible, we will run those live segments between **2:30pm and 4pm** EST depending on the course activity schedule for each class. Times will be confirmed during the first class and/or you will receive an updated course activity schedule by the start of the term. There will be an expectation that students will engage in another **60-90 minutes** of asynchronous learning at their convenience, in addition to the requirement for any assignments and groupwork to be completed outside of class

time. Recorded sessions will be posted in BrightSpace.

# **Required Textbook:**

Boone, Contemporary Business 3<sup>rd</sup> Canadian Edition with WileyPLUS

WileyPLUS price is \$89.00 CAD and it includes the full e-Text (online and offline for the term) and all the study tools. If you opt for a hard copy of the textbook, you will still have access to the online version while you wait. Please note: The textbook content will NOT be available until Sept. 8<sup>th</sup> at the earliest. You can purchase it in advance but you will not be able to view assignments and other related activities until this date. The WileyPlus Representative will be joining us for part of the first class to review how to use the on-line text.

In addition to the required textbook for the course, students are required to access a simulation from Praxar Serious Games (\$30.36 CAD), which they can be refunded for if they are successful in their application to work for the Sprott Student Consulting Group (see *Option B* below), as in this case their assessment portion will not come from this exercise. All students will participate in the practice exercises in weeks 7 and 8.

#### **Teamwork Option A: Praxar Simulation**

For all **Option A** students, the online simulation will take place during week 9 to 12, and details on how to purchase access for the simulation will be provided before the start of the course. Students who do not apply

for the experiential learning option (**Option B**) in Week 3 will, by default, be placed into this option and will be required to purchase the simulation.

# Teamwork Option B: Experiential Learning with the Sprott Student Consulting Group (SSCG)

BUSI 1800 students have the opportunity to apply to assist upper year experiential learning students on a project-based team, providing research support and otherwise helping them to successfully complete their project. If selected, the BUSI 1800 student will provide assistance to these students in the form of research support and other activities that help the students and client accomplish their project goal. Your mark for this portion of the course will the same mark received by the students for the overall project.

If you apply for one of these roles and are not selected, you will participate in the simulation (*Option A*) instead.

# **Required Technology:**

This course will be offered virtually and as such, students will be required to have access to the following in order to successfully engage in and complete the course:

- Access to a computer or a laptop with current versions of MS Word, MS Excel and MS PPT;
- Access to Internet in order to join the course and tutorials via Zoom;
- Access to a web cam (or one built into your computer/laptop); and
- Ability to record a video of yourself independently and/or for a group presentation.

Process: If an alleged violation occurs, all relevant documentation will be forwarded to the Dean. If the allegation proves true, the penalties may include; a grade of Failure on the submitted work and/or course; academic probation; a refusal of permission to continue or to register in a specific degree program; suspension from full-time studies; suspension from all studies at Carleton; expulsion from Carleton, amongst others. For a first offence, at a minimum, the penalty assigned will normally be a zero on the submitted work and at least a minimum full grade reduction of the final course grade. For a second offence, at a minimum, the penalty assigned will normally lead to a suspension from studies.
