Course Calendar Description: (From 2023/2024 graduate calendar): Analysis of investment requirements for individuals and institutional investors: liquidity, risk and return; portfolio design, construction, management

and control; performance measurement; capital market theory.

Prerequisite(s): FINA 5511 and enrolment in the Master of Finance program.

Course Description: The course aims to provide overview of various alternative investments as an investment asset class, including the key features, investment risks and characteristics.

Course Learning Objectives:

- 1. To examine the process of portfolio construction and decision making.
- 2. To help students become aware of recent advances in investment management which are essential for the efficient management of investments and portfolios. This is accomplished by exposing students to advances in investment management by assigned journal articles on relevant topics; and through a short group paper on an investment topic that may be of direct interest to a portfolio manager or an analyst in an investment house. The latter provides an opportunity to pursue a particular topic of interest.

Peer Evaluation for Group Work

To deter social loafing and ensure fairness in grading, you will be asked to assess the contribution of your fellow group members. This information will be used when assigning the grade for the final project. The procedure is as follows: Each student should take 100 points and allocate those points to the various members of the group (including him/her/themself) to reflect the contributions made by each member. For instance, if there are four members in a group and everyone contributed equally, each individual would receive 25 points. Conversely, if an individual contributed relatively little, the remaining group members might allocate few points to that member. To ensure that these peer evaluation scores are reasonable and free from personal bias, you will be asked to provide a detailed written explanation for your point allocation.
